Invoicing Access Fee

- 1) All Access Fees shall be invoiced upon:
 - a) The date of the transplant event; or,
 - b) The date that 20% of contract savings equal the applicable Access Fee; or,
 - c) As stated below.
- 2) **CAR T-Cell Therapy** shall be invoiced 20% of the savings under the INTERLINK contract, not to exceed the applicable Access Fee, even if the case does not progress to infusion. The Access Fee shall be invoiced:
 - a) The date that the case closes prior to infusion and a Closed Case Access Fee has accrued; or
 - b) The date the case closes.
- 3) For **Congenital Heart Defect (CHD)** INTERLINK will invoice accrued CHD Service

Access Fees on a quarterly basis:

- a) In-Network Facilities Access Fees are 15% of the savings under the INTERLINK contract; or
 - b) Out-of-Network Facilities Access Fees are 20% of the savings under the INTERLINK contract; and
 - c) For both (a) and (b), the total Access Fee shall not exceed \$10,000.
- 4) For **VAD** and **Heart Transplant cases**:
- a) If a patient has a heart transplant following a VAD insertion, within 30 days from original discharge date, the Access Fee shall be determined by the Multi-Transplant Access Fee term below.
 - b) If a patient has a heart transplant following a VAD insertion after 30 days from original discharge date, a new Access Fee will be invoiced for the Heart.
- 5) For **VAD Maintenance**: The Access Fee is 20% of the savings under the INTERLINK contract, not to exceed \$20,000 annually for the first year, and not to exceed \$15,000 annually each year thereafter. INTERLINK will invoice the VAD Maintenance Fees on a monthly basis. When VAD Maintenance contracts are accessed in conjunction with a Heart or Destination VAD contract, the first 12 months Access Fee shall not exceed \$15,000, rather than \$20,000.
- 6) For **Cancer Services** INTERLINK will invoice quarterly, the Access Fee:
- a) For In-Network Facilities is 15% of the savings under the INTERLINK contract; or
 - b) For Out-of-Network Facilities is 20% of the savings under the INTERLINK contract; and
 - c) For both (a) and (b), the total Access Fee shall not exceed \$15,000/year.
- 7) The **Bariatric Service Access Fee** is 15% of the savings under the INTERLINK contract, not to exceed \$3,500.
- 8) Any other Services not listed above shall have an access fee of 20% of the savings under the INTERLINK contract, not to exceed \$15,000. INTERLINK will invoice accrued Non-Transplant Services Access Fees on a quarterly basis.

Multi-Transplant Access Fee

For any two or more programs from the table above, the Access Fee shall be 100% of the highest Access Fee, plus 50% of each additional program Access Fee, not to exceed \$18,000.

Notice of Access Fees and Payment Terms and Responsibility

Payor will be notified of the current Access Fee for the applicable network service selected at the time Payor is presented with the patient specific contract (contained within INTERLINK's Step 2 Letter). Payment of the Access Fee is due thirty (30) days from the date of the invoice and is the

obligation of the Payor and not the patient. 9% interest shall be added for late payment. Patient's benefit limitations shall not affect Payor's Access Fee obligation to INTERLINK.
